## \$1,000,000 Red Packet Pool Promotion – Terms and Conditions

During the Promotion Period, all new and existing partners can win a chance to draw a red packet up to \$888 when the partner meets the promotion requirement.

**Please read the Terms and Conditions (hereinafter the “Terms”) as these are set out below.**

### 1. Introduction

- 1.1 The Promotion is eligible to both NEW and Existing partners who meet the criteria during the Promotion Period. Partner is also known as Introducing Brokers (IB).
- 1.2 Participants must be from the countries and regions covered by Clause 2.2 below.

### 2. Duration and Eligibility

- 2.1 The Promotion Period starts from 01 Jan 2023 to 31 March 2024 (End of trading day time is 21:00 GMT during US Daylight Saving time and 22:00 GMT during US Standard Time). For more details, please refer to the Trading Hours document.
- 2.2 The Promotion is only available in specific promotion areas, you may contact your account manager for more information.
- 2.3 Both new and existing partners are eligible for the Promotion. Partners who meet the criteria of clause 3 can receive the red packets automatically.

### 3. \$1,000,000 Red Packet Prize Pool

#### 3.1 How to receive it?

Partners can draw the red packets in AC Capital Market App. The number of draws will be settled and updated at 00:00 GMT every Sunday. Please login to [AC Capital Market App](#) to check and draw.

#### 3.2 How to win a chance?

During the Promotion Period, partners can win as many red packets as possible based on your weekly performance. When the referred accounts are active, the partner can win a red packet for every \$2,000 net deposit. Example:

Referred account(s)* Total net deposits amount**	Referred account(s) Trading status	Number of draws received
\$2,000	Active	1
\$4,000	Active	2
\$6,000	Active	3
And so on	Active	No limit

\*The Promotion only calculates the total net deposits amount from retails accounts directly invited by partners.

\*\*Total net deposits amount = Total deposits amount – Total withdrawal amount.  
Please note that in the case of accounts under the same name, transfers between them will not be included.

- 3.3 The red packets will be kept for two weeks after the Promotion Period, which means the red packets must be drawn by 14 April 2024 at 20:59 GMT (summer time).
- 3.4 To help partners to understand The Promotion requirement, here are some examples.

**Case (1): Met the requirement this week**

Partner: Mr. Wang

Total net deposits amount of this week: \$4,000

Referred accounts' trading status of this week: Active

Number of draws received this week: 2

$\$4,000 / \$2,000 = 2$  Chances

**Case (2): Did not meet the requirement this week and amount will be accumulated to next week**

Partner: Mr. Wang

Total net deposits amount of this week: \$1,000

Referred accounts' trading status of this week: Active

Number of draws received this week: 0

----- (Performance data will be accumulated to next week)

Total net deposits amount of this week: \$5,000

Referred accounts' trading status of 2nd week: Active

Number of draws received this week: 3

$(\$1,000 + \$ 5,000) / \$2,000 = 3$  Chances

Notice: The system calculates deposits and trading volume of the week from 21:00 GMT (summer time) last Saturday to 20:59 GMT (summer time) current Saturday after the market closes each week.

- 3.5 Partner who met the requirement will receive the notification from [AC Capital Market App](#) after weekly settlement finished, partners can click the notification or open the red packet' promotion page in App to draw your red packets.
- 3.6 The red packet amount will be assigned randomly by system. The maximum amount of each red packet is \$888.
- 3.7 The Red Packet amount will be credited to the trading account. Under the red packet' promotion page in AC Capital Market App, partners can check the amount of each red packet in the record section.
- 3.8 The Red Packet can be used for trading, transfer or withdraw purposes.

#### 4. Other Conditions

- 4.1 AC Capital Market reserves the right to decide whether there is any abuse, attempt to exploit with the Promotion, or breach of these terms and conditions, and take corresponding actions, including but not limited to canceling the Promotion, suspending accounts, recovering losses, etc.
- 4.2 AC Capital Market reserves the right to deliberate account' trading status.
- 4.3 The company reserves the right to terminate the promotion at any time if it cannot continue due to objective reasons.
- 4.4 Participants will be bound by Terms and Conditions and strictly comply with the compliance requirements of AC Capital Market.
- 4.5 AC Capital Market reserves the right to amend the Terms of the Promotion at any time and will be effective once it is released.
